

# Nova Scotia Examination: English 10

## 2025–2026 Semester 2 Key Information & Resources

**Overview:** The Nova Scotia Examination: English 10 examination is written at the end of the course, in two one-hour sessions during regular class time on June 18 & 19, 2026. The examination consists of four reading/viewing passages with 35 multiple-choice questions and one persuasive writing task.

The NSE English 10 is scored by course teachers using the provided Marking Guide. The examination represents 20% of the final course grade.

**Adaptations:** Any adaptations provided to a student during the examination must have been provided to the student throughout the course, must be documented in TIENET, and must not compromise the validity of the examination. Refer to the NSE Information Guide for further details.

Please note: The Nova Scotia Read-aloud (NSA-RA) platform will not be available for English 10. Read-aloud audio files are available via USB stick – no registration is required, and *each school* will automatically receive two USB sticks (one for each day of the examination). Schools are responsible for coordinating student access and ensuring appropriate supervision during the examination.

  - The duration of the examination is 2 hours, split over two one-hour class periods on June 18 and 19.
  - The examination will be administered and scored by classroom teachers per usual practice. The examination will not be scored provincially.
  - Examination materials must **not** be returned to the Department of Education and Early Childhood Development. Schools are required to retain and secure all materials for a minimum of one year, or longer in accordance with regional retention policies, before securely disposing of them.
